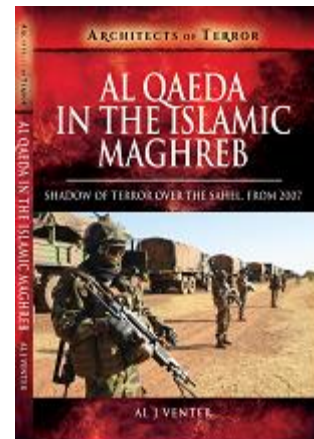
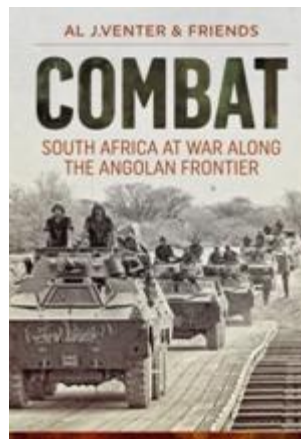
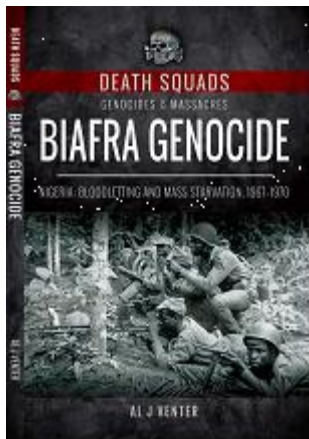
3. Personal Note from Al J Venter of 32 Bn

"I have had my biggest battle of all; with Cancer. After a series of radiation treatments at Guys Hospital in London, I was yesterday given the all clear by my Oncologist. The past year has been rather awful and started a year ago when I went down with a critical deep vein thrombosis attack while writing my latest nuclear book and that took four months to come right. But come right it did, and cancer or not, I stayed on top by continuing with my regular pool time which is now up to 500 or 600 metres three times a week. I place my survival firmly in the hands of the Lord and also a rigorous exercise routine that keeps an Oupa like me relatively young. Gabriela also helps.



My latest book on Biafra is just out which contains quite a bit on SA involvement. It will be followed by *COMBAT* about our bush war due out towards the middle of next year. I am currently working on my next project about the European Command Force acting against AQIM of Al Qaeda in South Sahara. It is not an intensive conflict but covers an enormous region half the size of Europe. The USA is involved with an extensive Drone effort based in neighbouring Niger. I have already done some work on AQIM and released a book earlier this year through Pen & Sword.

## 6. Remembrance Day Parade in Mossel Bay on 11/11/2018

Deon Potgieter of the SA Legion advises that "... more than 90 years ago the Community of Mossel Bay decided to erect a War Memorial to honour those Local Citizens who had laid down their lives in WW1. Fondse is deur die gemeenskap uit donasies en die hou van menige bazaars ingesamel om vir die oprig van 'n monument by Die Punt te betaal, op 'n perseel wat deur die munisipaliteit geskenk is. On 28/09/1928 the Cenotaph was unveiled by Maj-Gen Sir HT Lukin, KCB, CMG and DSO & Bar who was the Commander of the SA Forces that went to War in Africa and Europe in 1915. The Cenotaph was designed by a local architect, Mr WJ Delbridge, and modelled on the Cenotaph in White Hall, London, England.

Op Sondag 11/11/ 2018 het die Blaize Away Shellhole 'n Herdenkingsdiens en Parade by die Senotaaf aangebied. The proceedings was in honour of all those from Mossel Bay who paid the ultimate price during WW1, WW2, the Korean War, the SA Border War and more recently the Iraq War".



## 7. Shape and Weaponry of the Modern Warship

Arne reported in his MN that Hanko, that one of four Hamina class missile fast attack craft in the Finnish Navy, carry four RBS-15 SSMs and eight Umkhonto SSMs made in the RSA.



## 8. World's Oldest Commissioned Warship Afloat

The USS Constitution, the world's oldest commissioned warship afloat, and its crew headed underway from the ship's berth in Charlestown, Massachusetts, on 19/10/2018, in commemoration of the ship's launching 221 years ago on 21/10/1787.



### 9. Initial Plan by the Pentagons to Create a Space Force

According to Arne's MN, parts of the USN, USAF and US Army would move into a sixth branch, the US Space Mission, according to an internal draft of the Pentagon's plan. This early draft provides a glimpse into a 21st-century approach to creating a new service branch, an endeavour not undertaken since 1947. The draft document calls for the Space Force to absorb parts of Air Force Space Command, the Navy's Space and Naval Warfare Systems Command, the Naval Satellite Operations Centre and the Army's 1st Space Brigade.

### 11. Exercising Right of Free Passage

The USN is drafting a plan to sail ships and flying aircraft near China's territorial waters in the South China Sea and Taiwan Strait in freedom of navigation operations to demonstrate the right of free passage in international waters. The proposal means US ships and aircraft would operate close to Chinese forces. The defence officials emphasized that there is no intention to engage in combat with the Chinese.

### 12. Responding to China's Challenge at Sea

In Arne's MN it was stated that China is building a Navy that intends to challenge the USA and the broader international community on all the high seas across the globe. Defence leaders have been highlighting China's investments in new ships, including aircraft carriers and nuclear-powered fast-attack submarines, to thwart US carrier groups. The contraction of the overall size of the USN effectively invited China and other nations to enter into a naval arms race with the USA. It is critical to quickly answer President Trump's call for a 355-ship Navy if we are to avoid a disastrous war at sea..

### 14. Kompliment deur Andre Brink van die Infanterie

"Lede kla met reg oor probleme en swak diens wat ervaar word, maar ons is verplig om ook ons positiewe ervarings te deel. Dalk beur dit ons 'n bietjie op, veral as ons weer bewus word van die mediese koste in die privaat sektor! In my geval het ek op 15/08/2018 ontdek dat ek nie met my linkeroog kan sien nie en het op 16/08/2018 vir dr Haarhof by 1 Mil Hosp se Oogkliniek gaan spreek. Na ondersoek het hy beslis dat 'n noodoperasie nog dieselfde dag en spesifiek deur dr Potgieter by die Centurion Ooghospitaal gedoen moet word. Hy het persoonlik gereël dat dit dieselfde aand plaasvind en het self geskarrel om die nodige magtigings te bekom. Voor die operasie het hy ook weer kom kyk of alles reg verloop. Die operasie, teen ongeveer R130 000, het die herstel van 'n retina-loslating en reuse skeur, asook 'n lensvervanging, behels. Indien daar gesloer is sou ek waarskynlik alle sig in die oog verloor het. Die herstelproses is nog lank maar vorder goed. Ek het net dank en waardering vir drs Haarhof en Potgieter se spoedige en professionele optrede en vertrou dat my ervaring dalk vir iemand 'n sprankie hoop sal bied!"

#### 15. Kommentaar oor ons Mediese Stelsel. Peet Duncan van die Infanterie verwittig soos volg:

“In die verlede is die modernste hospitale gebou, toegerus en met kundige mediese personeel beman en was die afgetredenes van uitstekende mediese sorg voorsien. Toe vrede kom was dit tog duidelik dat afskaling moet plaasvind en toe reeds moes ernstig besin word oor befondsing vir die toekoms. Myns insiens moes afgetredenes nooit in geheel vrygestel gewees het van bydraes nie en moes daar vroeg reeds verhogings vir alle bydraers gewees het. Ek glo nie daar is enige mediese fonds waar bydraes na 60 staak nie. Ons is ten spyte van alles nog in n gunstige posisie.

Elkeen van ons maak sy eie keuses. Talle van ons het gekies om ver van 'n militêre hospitaal af te tree, maar met operasies en ander behandelings is koste uit eie sak ons voorland, want daar kan nie van die SMMVF verwag word om dienste na elke individu se behoefte of voorkeure te skik nie. Ons is egter steeds geregtig op goeie en effektiewe dienslewering. Wat egter veel te wense oorlaat is die swak kommunikasie. Oproepe word keer op keer gemaak en dit is bykans onmoontlik om die regte persoon te kontak, om afsprake te maak en om antwoorde te kry. Selfs vele oproepe deur my plaaslike geneesheer het niks opgelewer nie. Dit het vier maande geneem om 'n afspraak by 2 Mil Hosp se Afd Ortopedie te kon maak en twee maande later moes ek 'n Mediese Student sien wat my nie kon help nie. Ek het egter vasgebyt en kon met blote geluk met dr Arlow telefonies praat, wat gesorg het dat ek agt maande later 'n knieervanging kon ondergaan. Wat 'n verligting en groot sukses. Ek het vir my knie se vervanging 'n kwotasie by Med Clinic Hospitaal in Mosselbaai vir R135 000 gekry. Met my persoonlike reis- en verblyfuitgawes in ag geneem, bly my behandeling steeds 'n bonus.

#### 16. Swak Behandeling van AO1 A. Koen van die TDK

Rouen Heiberg van Afd Inl rapporteer dat hierdie 80jarige Veteraan 'n internis in George in Mei 2018 besoek het, waartydens 'n ongereelde hartritme gediagnoseer is. Na hierdie besoek is 14 dae gewag vir magtiging sodat 'n hartskokprosedure in MediClinic Hospitaal in George uitgevoer kon word. Opvolgbesoeke is in Jul 2018 en op 11/10/2018 aan dieselfde internis gebring, waartydens hy aanbeveel het dat die hartskokprosedure herhaal word. Verskeie pogings deur die internis se praktyk en die George Siekeboeg om magtiging te bekom vir opname in die MediClinic Hospitaal George was onsuksesvol. Die internis se ontvangsdame het by geleentheid teenoor AO1 Koen opgemerk dat sy keelvol gesukkel is.

Die George Siekeboeg is op 23 en 24/10/2018 besoek maar magtiging kon steeds nie verkry word nie. 'n Lid by 2 Mil Hosp het bepaal dat AO1 Koen na 2 Mil Hosp moet kom, maar later is die George Siekeboeg ingelig dat 2 Mil Hosp nie oor 'n Kardiologie-afdeling of kardioloog beskik nie en dat hy na die Provinsiale Hospitaal op George verwys word. Die lid was bereid om dit te doen, maar nadat George Siekeboeg weer met 2 Mil Hosp skakel, is bepaal dat hy na die Ongevalle-afdeling by MediClinic moet gaan. Toe hierdie hospitaal magtiging vir opname versoek is dit geweier en is hy opdrag gegee om na die Provinsiale Hospitaal op George te gaan. Sedertdien is verneem dat hierdie hospitaal nie die prosedure sou kon uitvoer nie en dat hy in elk geval van daar na Groote Schuur Hospitaal verwys sou word. AO1 Koen het intussen self navrae begin doen en poog om na 1 Mil Hosp te gaan siende dat daar wel 'n kardiologie afdeling is.

Onsuksesvolle pogings om magtiging vir dringende mediese prosedures te verkry is onaanvaarbaar en kommerwekkend. Ons mediese voordele behels immers 'n kontrak tussen die SMMVF wat met dringendheid en professionaliteit nagekom behoort te word. Almal kan nie in die nabyheid van militêre hospitale woon nie en wat gaan gebeur wanneer mediese diens nie in jou onmiddellike omgewing gelewer kan word nie? Ons kry nog altyd uitstekende mediese diens by die Militêre Siekeboeg op George en ons het groot waardering daarvoor. Gebeure soos hierdie laat ons egter twyfel oor die volhoubaarheid van ons mediese diens. Opmerking. Die geval is onder die aandag van 'n goedgesinde afgetrede mediese offisier gebring, wat soos volg rapporteer:

“Ek hierdie aangeleentheid met dr Anushka Jamuna van die SMMVF bespreek, asook ander gevalle waar lede na provinsiale of militêre hospitale verwys word, welwetend hierdie dienste nie by die provinsiale hospitale gelewer kan word nie. Sy het onderneem om die kwessie met die SAMGD op te neem”.

"Rifleman Nic Els of 1 SWA Spes Unit appears on the photo here below taken in 1983. The pictures show him confident, reins in one hand and rifle in the other. Unfortunately a landmine blew off his legs and killed his horse on 06/06/1983. The mine also wounded a number of other men of the SWATF and killed a few of the other horses that day. Nic served in an exceptional unit, which fought their war on horses and motorcycles. They could track the enemy at speeds of up to 15 km/h for a solid four hours, and go as fast as 30 km/h once they caught the scent. SWAPO (PLAN) terrorists feared this highly mobile unit and did everything in their power to hamper them, including the use of landmines. To go from elite, highly mobile mounted soldier, to an amputee in seconds was a shock to Nic and it took many years for him to adapt".

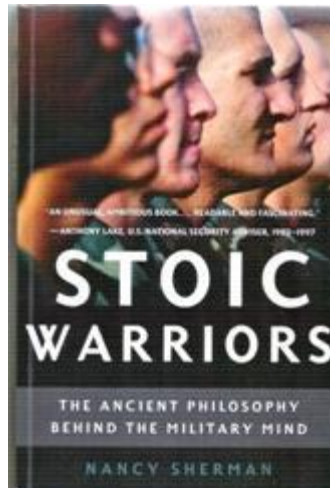
## 21. Herdenking van die Bosoerlog

## 22. *Stoic Warriors : The Ancient Philosophy Behind the Military Mind*

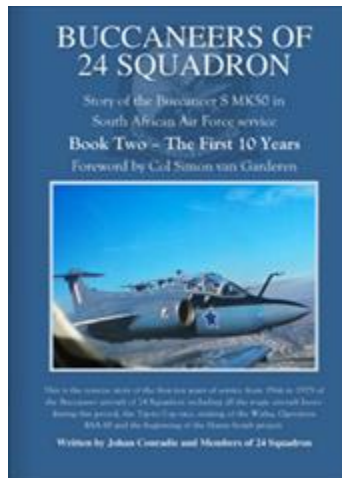

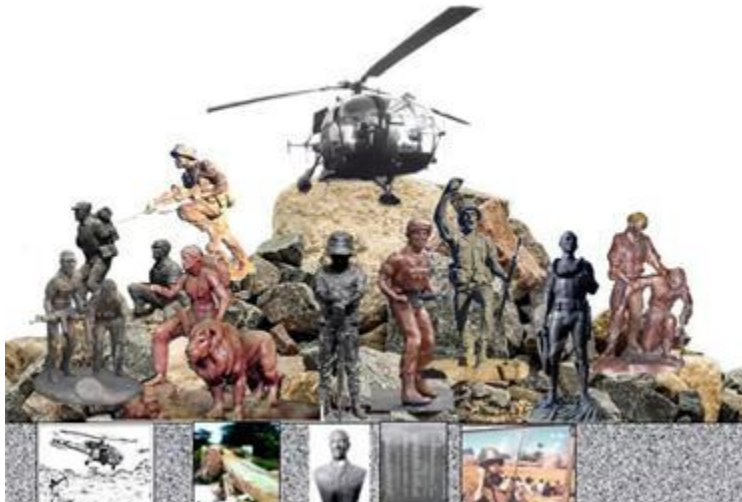

Yours were the eyes of our shared mind that fleshed into action the deeds we don't talk about. That's why we can't speak about the war to outsiders.

Only our comrades understand, those greying men who were once part of our common mind. They know what we did and why we did it and they don't judge. They remain loyal to the grave where they take our secrets.

When we left the war, our severance from the shared mind disabled us, but also released us. We became individuals again and built our lives alone and moved on.

Before that we were not ourselves, yet were ourselves, collectively.

Yes we were Infantrymen, but what were we really? We were a tribe, a shared mind of boys whose job was to kill. That was the world to which we belonged.

A part of me has never been comfortable with that, while a bigger part misses it more.

### ASPECTS CONCERNING OUR PENSION FUND (GEPF)

#### 34. Statement Issued by AP Stemmet on Behalf of AMAGP Regarding the VBS Bank

It must be realized that although the Public Investment Corporation (PIC) is the primary investment agency, approximately 87% of the PIC investment capacity is executed on behalf of the GEPF. Many dubious PIC investments have now come to the fore. The GEPF Responsible Investment Policy dated 16/11/ states that '... according to the GEPF's investment policy, the GEPF's assets are invested to deliver optimal returns at acceptable levels of risk. The Board of Trustees of the GEPF is the fiduciaries entrusted with the achievement of the investment objectives...' It must be asked whether the GEPF Trustees financially perform in accordance with its own promulgated Responsible Investment Policy?

With the bribery revealed thus far in the VBS Mutual Bank scandal, it is inconceivable that those in control of the largest pension fund in the RSA were never been on the receiving end of an attempted bribe or acts regarded as corruption which warranted reporting to the Directorate for Priority Crime Investigations (DPCI). Section 34(1) of this Act. This is very clear and states that '... any person who holds a position of authority and who knows or ought reasonably to have known that any other person has committed an offence, must report such knowledge or suspicion to any police official'. We hope the DPCI will start to interrogate those charged with governance at the GEPF and the PIC for what appears to be an absence of visible support in the fight against corruption. We also hope that those in control at the GEPF and PIC continue to sleep easy at night, as we know that the pensioners of the GEPF will not.

#### 35. New Issue of the GEPF Monitor
