23. Lede van die SWAGM en Koevoet Protesteer in Windhoek

Albert van Zyl van 32 Bn en Afd Inl rapporteer oor 'n berig wat in Die Republikein van 20/12/2017 verskyn het. Ongeveer 400 gewese lede van die SWAGM en Koevoet is reeds die afgelope twee jaar met 'n sitstaking buite die Rooivlag-Kommandosaal in Katatura besig, om aan te dring op vergoeding en dat hulle deur die Namibiese Regering as Militêre Veterane erken word. Hulle dring ook daarop aan dat die \$N30 miljoen wat die destydse regering van die RSA aan Namibië betaal het, as bron gebruik word om aan hulle 'n militêre pensioen te verskaf. Op 18/12/2017 het dié 400 lede 'n protesoptog na die Staatshuis in Windhoek onderneem, maar is deur die Namibiese Polisie gedwing om na hulle skuiling by die Kommandosaal terug te keer. Die Namibiese regering het adjunk-president Nickey Iyambo aangestel om met die groep oor hulle griewe te onderhandel, maar die eerste vergadering moet nog plaasvind.

24. Maintenance Delays and Operational Defects Impact on the SAN

According to Arne's MN the SAN logged 67% of the twelve thousand sea hours allocated to the Maritime Service of the SANDF for the 2016/17 financial year. According to the Department of Defence annual report for the reporting period, which was made public at end Nov 2017, the Navy only logged 8 131 hours of sea time due to the unavailability of vessels at the required level of capacity.

25. Last Photo of Crew of the Missing Argentinian Submarine

* This is the final photograph of all 44 crew members of missing Argentinian submarine, the ARA San Juan. The picture was taken on 01/08/2017 at the Naval Base in the Atlantic resort of Mar del Plata, which shows the 43 men and one woman who have been given up for dead.

* Subsequently the Chief of the Argentinian Navy, Admiral Marcelo Eduardo Hipólito Srur, has been sacked and is the first known disciplinary action taken since the loss of the submarine.

27. French Military Using Eagles to Hunt Rogue Drones. Olivier Henning of the Medics have provided the following report:

Following incidents of drones flying over the presidential palace and restricted military sites, the French Air Force has trained four golden eagles to intercept and destroy the rogue aircraft. The photo shows a golden eagle grabbing a flying drone during a military training exercise at an Air Force Base in France.

28. Tekort aan Teaters by 1 Mil Hosp

Dirk van Rooyen van die ADK rapporteer dat sy "... vrou byna sewe weke moes wag voordat `n teater by 1 Mil Hosp vir haar operasie beskikbaar was. Ek verneem dat daar slegs een teater operasioneel is, dat een gesluit is vanweë `n virus wat daar ontdek is en dat een teater opgradeer sou word maar dat die kontrakteur bankrot gespeel het. Vir my is dit onaanvaarbaar dat so `n situasie by ons hospitaal kan ontstaan".

29. Mediese Rekening vir Neels van Tonder van Afd Inl

In Okt 2017 het ek 'n hartprobleem ontwikkel en het magtiging van die Siekeboeg in Nelspruit ontvang vir 'n mediese prosedure deur 'n plaaslike hartspesialis in die hospitaal in Nelspruit wat 'n week later gedoen was. Ons SMMVF het toe 'n derde van die spesialis se rekening volgens die skema se tarief betaal en my ingelig dat ek self vir die betaling van die res van die spesialis se rekening aanspreeklik is. Ek het die magtigings wat deur die Siekeboeg in Nelspruit gereël is aan die Fonds gestuur met die versoek dat hulle die res van rekening ook betaal, maar het nog nie op my skrywe geantwoord nie. Intussen hou die spesialis aan om vir my rekenings te stuur. Dit kan binnekort 'n onaangenaamheid word en ek wil nie graag 'n swak verhouding met die enigste hartspesialis in die dorp hê nie".

30. Letter to the RFMCF. The following letter was sent to the RFMCF on 20/12/2017 by one of our members who is concerned about the state of our Medical Fund:

FUNCTIONING OF THE RESERVE FORCE MEDICAL CONTINUATION FUND

At the Newsletter for the Military Veterans we have received a number of enquiries about present arrangements at the RFMCF. We have learnt that after a recent operation, a member of the RFMCF was presented with an account by the Surgeon which he is expected to pay, while the following note at the Sickbay of the Area Military Health Unit in Potchefstroom is reason for concern:



The following appears on the Webpage of the RFMCF, but it obviously appears that the RFMCF is not adhering to its own mandate:

“The Regular Force Medical Continuation Fund (RFMCF) was established on 01 January 1964 as a private fund and is therefore not governed by the financial authority of the Department of Defence. The aim of the fund is to provide medical, dental and hospital treatment to members of the Regular Force who retired or retired on pension, on or after 01 January 1964, and their families and the families of members of the said Force who died on or after the said date. Furthermore, the fund was established in order to continue to provide all medical benefits to which a member of the Regular Force was entitled to during their term of service. The RFMCF was created by the Defence Act as a SANDF Fund. The Fund therefore has to comply with the Defence Act and the General Regulations promulgated by the Minister of Defence in terms of the Defence Act.

The RFMCF is committed to the principles and practices of fairness, openness, integrity and accountability in all dealings with its stakeholders. The RFMCF, governed by the Defence Act, 42/2002 and the General Regulations Chapter XV promulgated in terms thereof, has been adhered to. The Fund is also fully committed to the principles of the Code of Corporate Practices and Conduct set out in the King Report on Corporate Governance”.

It is respectfully requested that that the Management Council of the RFMCF, or yourself, issue a statement in which the present situation regarding the responsibility of the members of the RFMCF to pay for their own medical services is explained, in order to adhere to the principles and practices of fairness and openness to which you profess to on your web page.

31. Reaction by Dr Anushka Jamuna of the RFMCF on 21/12/2017

Thank you for your letter and your concerns are noted.

I am unaware of what Newsletter you refer to. It does not appear to be any formal nor endorsed communication from the RFMCF. There is a formal complaints/queries channel and it is hoped members use those provided so that each member is afforded an opportunity to raise issues that bear directly on them.

Further to this, the notification you mention in a military facility/sick bay is something the RFMCF cannot comment on.

No such communication/nor instruction was issued to the SAMHS on such a matter. You will remember that an official communication was sent out to members around July 2017, whose contact details the Fund has, indicated the implementation of Fund tariffs, and clearly stated that members should bring to the attention matters of co-payment, and the Fund will deal with these cases, provided that all criteria in terms of authorities, and availability of clinical services or not are met.

FUNCTIONING OF THE RFMCF

1. Your e-mail message of 21/12/2017 refers.

2. Your response is appreciated. Please note that the Newsletter for the Military Veterans has no formal standing, but serves as a forum for the Veterans where their concerns are noted. Your suggestion that the formal complaints channel of the RFMCF be used and that matters of co-payment be reported, will be conveyed to the Veterans in the next Newsletter.

3. The members of the RFMCF will be relieved to learn that the instruction at the Sickbay in Potchefstroom was not issued by the RFMCF. However, it is of concern that the telephone number on the notice is that of the RFMCF and it is requested that this be clarified.

33. Tony Dippenaar van Cela

“Ek het navraag gedoen oor die verwarring wat rondom die beweerde bybetalings aan die SMMVF en sover ek kon uitvind, is daar in wese geen werklike verandering nie. Die lede se voordele is dieselfde as vir dienende lede en is verskans in die Verdedigingswet en die Algemene Regulasies.

Dit is wel korrek dat indien daar 'n generiese ekwivalent beskikbaar is, 'n lid die verskil in koste moet inbetaal indien daar op die oorspronklike produk aangedring word. Indien enige lid 'n rekening vir mediese dienste ontvang, moet die kwessie onmiddellik by die Fonds aanhangig gemaak word”.

35. Gedagtes oor Oscar Cardoso van Afd Inl en die SALM

* Koos Louw van die SAV noem dat hierdie Veteraan van die Portugese Veiligheidsdiens en die SAW 'n besondere man was wat 'n groot rol gespeel het. Hy is na jare se goeie diens deur genl Earp by SALM HK as persoonlikebeskermingsoffisier en pistoolskietinstrukteur aangestel is. In die vroeë negentigs het hy na Portugal teruggekeer en hom in Alentejo gevestig. In Nov 2017 was ek in Portugal en het by die Portugese Mariniers gaan kuier. Groot was my plesier om te hoor dat Oscar na sy aankoms in Portugal as skietinstrukteur by die Mariniers diens gedoen het en 'n wonderlike bydrae daar gelewer het. Oscar het een van die mooiste versamelings gewere en handwapens gehad waarvan 'n mens kan droom. Hy en sy vrou was ons goeie vriende en ons gesin het sy pragtige hond geërf toe hy landuit is. Hierdie is nog 'n karakter wat met vrug nagevors kan word”.

* Manuel Ferreira of the SAAF adds that Oscar was stationed in Mozambique as a member of the Portuguese Secret Service (DGS). He had travelled to Lisbon for work when the military coup of 1974 took place. He was arrested by the Military Junta, but eventually escaped by making his way to Spain. He joined the Rhodesian Army, serving with Ron Reid-Daily, before joining the SADF. He served at Int Div (DCC) before transferring to SAAF Int”.

36. A Christmas Story During Op Savannah

* On the web page at *Operation Savannah the Secret War 1975-1976*, Herman Les Lessing referred to the story of Rfn Malcolm Wolverson who got separated from his fellow soldiers while leaving the observation post, known as OP Beetle, in Dec 75. He had to survive on his own, while in between he was in contact with three different groups of enemy. He killed and wounded a number of them and took possession of firearms of some of the others. An unknown hero who did not even receive a Pro-Patria medal. I am busy putting this episode together in conjunction with him and will make it available for storage in our archives as soon as it is ready.

* Mark Goller explains that on 22/12/1975 Col Swart of the Cavalry ordered Lt Johan Blaauw to occupy Beatle Hill with a battle team and also to reinforce the OP. Johan left under cover of darkness and crossed the Queve River with the pontoon and by daybreak they were ready to start climbing the mountain. They followed a track leading up onto the mountains to where the road petered out, where he left some to protect the vehicles and the others to take what armaments and ammunition they could carry and moved forward on foot. They came under fire which they neutralized and found eleven of the team that had manned the OP. They brought them to the safety of the vehicles and the pontoon where an ambulance was waiting to evacuate the wounded. Of Rfn Malcom Wolverson there was no sign and it was accepted that he had probably been captured or killed. However, three days later, on 25/12/1976, Wolverson arrived at Cela on a bicycle. After becoming apart from the rest of the section and finding himself behind the attacking enemy, he had started walking living off the land, eating what he could find. Later he had come across a hut where he liberated a bicycle and pedaled like hell until he found a signpost that showed him the direction to Cela. It was believed that he had killed three Cubans during his journey.

In 1990 is die Fort aan die Stadsraad van Tshwane teruggegee en die persoonlike items sou aan die families terugbesorg word. Dit het nie gebeur nie en alle pogings van die familie se kant om die items op te spoor het tot dusver doodgeloop. Hulp van enige van die Veterane sal waardeer word. My e-posadres is marie.m@mweb.co.za".

* Andy Malan van die historiese Kavallerie noem dat hy die kwessie "... breedvoerig met Marie-Helene bespreek het. Ek het genoem daar met met die sluit van die museums drie beskikkingsrade gehou is en dat die Rade hulle bes gedoen het om persoonlike skenkings aan die families terug te besorg, maar blykbaar het dit nie met hierdie skenking gebeur nie. Daarna kon ander museums en versamelaars uitsoek wat hulle graag wou hê en alles is behoorlik op uitreikingsbewyse uitgereik en geboekstaaf. Agterna het ek en Andy May ook nog twee Rade van Onderzoek gedoen oor spesifieke items wat vermis geraak het. Dit laat my altyd bewoë met gedagtes wat onwillekeurig hunker na makkers wat nie meer daar is nie".

I see that Solidarity is taking them to court on the prior acts, forcing them, but so far we have not done anything like that. Our viewpoint is that the members of the pension fund, the serving members, as well as the people already on pension, are the real owners of the fund. The trustees are supposed to administer the fund. But how they do it we do not know".
